Town Board Minutes January 2, 2008

Present: Supervisor William A. Eagan, Councilmen James E. Pluta and Richard K. Hawkins, Councilwomen Cathleen M. Dobson and Cathy A. Maghran.

Also Present: Highway Superintendent Telaak, Town Attorney Downey, Deputy Supervisor McGirr and Code Enforcement Officer Ferguson.

Supervisor Eagan stated that he wanted to clarify comments made at the last meeting in regards to topsoil and backfill being brought to his and Councilwoman Dobson?s properties. He noted that at that time and according to the Code Enforcement Office, the Town Board did not require residents to apply for a permit. There was no violation of the code at that time because there was not a code in place to define the necessity for a permit for fill.

Supervisor Eagan also stated that comments made by Deputy Code Enforcement Officer Lisowski also need to be clarified by Code Enforcement Officer Ferguson.

Supervisor Eagan asked Code Enforcement Officer Ferguson to clarify the events of the day when Robert Telaak came in and requested information on a Special Permit for Dumping of Material.

Code Enforcement Officer Ferguson stated that Robert Telaak came in October and wanted to know about a dumping permit. He was given the form, but he did not return because he said he wasn?t going to do it. He returned in December and initially was given the wrong form, but then was given the right one. He filled out the form and submitted it.

Supervisor Eagan asked if that all happened on the same day.

Code Enforcement Officer Ferguson said yes.

Supervisor Eagan noted that it really didn?t happen the way Deputy Code Enforcement Officer Lisowski said other than Robert Telaak came in to see you.

Code Enforcement Officer Ferguson said yes.

A motion was made by Supervisor Eagan and seconded by Councilman Hawkins to adopt the minutes of the December 19, 2007 regular meeting.

A motion was made by Councilman Pluta and seconded by Councilman Hawkins, upon review by the Town Board, that fund bills on the Abstract dated December 27, 2007 in the amount of \$47,026.66 be paid.

Highway Superintendent Telaak inquired as to why his Deputy Highway Superintendent had not received a raise this year.

Supervisor Eagan stated that it was explained to him during the budget process. Larry Rogers came on board late summer and has not been employed long enough to qualify the Town Board to grant him a raise.

Highway Superintendent Telaak stated that there was a brand new person starting in the Court Clerk?s office that receives a raise and has no experience. How can the Town Board come up with this decision to give one man nothing and another a 3 percent raise?

Supervisor Eagan stated that he doesn?t know where his information is coming from, but will try to answer his question. He stated that it was never the Town Board?s intention to do what you are implying. I can tell you that the new court person is starting at \$12.45 per hour, which is the old rate.

The Deputy Town Clerk position, previously held by Karen Ellis, was reduced by \$4,000. So too, was the other PT Clerk, which was reduced to \$12.45 per hour.

Highway Superintendent Telaak stated that his information came from the sheets he held in his hand.

Supervisor Eagan stated that the sheets Highway Superintendent Telaak has had been updated and the Town Board had agreed to reduce those salaries.

Highway Superintendent Telaak questioned why the Assistant to the Supervisor was receiving more than a 3 percent raise.

Supervisor Eagan stated that in the past this position either received a very small increase or no increase at all. A survey was completed to include as many towns as possible within Erie County and outside to compare the rate of pay for this position. Her salary was never adjusted to where it should be, so we gradually adjusted it and put it where we felt it should be. It was agreed unanimously by the Town Board of 2007.

Highway Superintendent Telaak noted that the problem was not with the receiving of the raise itself, but with the fact that it was more than 3 percent.

Supervisor Eagan stated that she never received a full raise in the previous years and the Town Board is now making up for it. A one-time make up.

Highway Superintendent Telaak stated that he was told no when he requested more than a 3 percent raise.

Supervisor Eagan asked Highway Superintendent Telaak how much he was asking for.

Highway Superintendent Telaak asked to be brought up to what the other towns in this area were making.

Supervisor Eagan stated that this was all explained to him last year. The numbers that Highway Superintendent Telaak brought in were from 2003. Councilwoman Dobson and Town Clerk Shenk worked together to canvass towns to obtain recent information which resulted in showing that your salary is in line. He was not entitled to a 10 percent raise as Highway Superintendent and 16 percent raise as Parks Superintendent.
